## **Milestones Supplemental Guide**

This document provides additional guidance and examples for the Medical Toxicology Milestones. This is not designed to indicate any specific requirements for each level, but to provide insight into the thinking of the Milestone Work Group.

Included in this document is the intent of each Milestone and examples of what a Clinical Competency Committee (CCC) might expect to be observed/assessed at each level. Also included are suggested assessment models and tools for each subcompetency, references, and other useful information.

Review this guide with the CCC and faculty members. As the program develops a shared mental model of the Milestones, consider creating an individualized guide (Supplemental Guide Template available) with institution/program-specific examples, assessment tools used by the program, and curricular components.

**Patient Care 1: Clinical Reasoning: Differential Diagnosis**

**Overall Intent:** To formulate and iteratively evaluate a list of potential toxicologic exposures responsible for a patient's clinical findings

Milestones	Examples
<b>Level 1</b> <i>Identifies a patient's problem with a potential toxicologic cause</i>	<ul style="list-style-type: none"> <li>• Identifies a toxidrome in a patient with unknown poisoning</li> </ul>
<b>Level 2</b> <i>Synthesizes all available data, including interview, physical examination findings, and preliminary laboratory data, to define the differential diagnosis</i>	<ul style="list-style-type: none"> <li>• Creates a toxicologic differential diagnosis for acute liver injury</li> <li>• Prioritizes differential diagnosis based on history and physical exam</li> </ul>
<b>Level 3</b> <i>Modifies and refines evidence-based differential diagnosis based upon clinical course and data, and avoids premature closure</i>	<ul style="list-style-type: none"> <li>• Recognizes progression of toxidrome on examination and adjusts treatment plan appropriately, such as progression of serotonin syndrome</li> <li>• Recognizes mimics of a toxidrome, such as encephalitis vs anticholinergic syndrome</li> <li>• Considers rhabdomyolysis for an increased aspartate aminotransferase (AST) in addition to acetaminophen poisoning</li> </ul>
<b>Level 4</b> <i>Recognizes toxicological presentations and/or conflicting diagnostic results that deviate from common patterns and require more complex decision-making</i>	<ul style="list-style-type: none"> <li>• Broadens sample testing to include more esoteric testing such as, heavy metal testing in altered mental status</li> <li>• Considers ethylene glycol poisoning when a patient presents with elevated lactate levels</li> </ul>
<b>Level 5</b> <i>Develops guidelines or algorithms/protocols used for education and guidance for learners, clinicians, or poison specialists</i>	<ul style="list-style-type: none"> <li>• Develops/updates diagnostic algorithm of acute toxic alcohol poisoning</li> </ul>

<b>Patient Care 2: Ordering and Interpretation of Studies</b> <b>Overall Intent:</b> To understand the types of testing that assist in diagnostic and treatment decisions and apply the test results	
Milestones	Examples
<b>Level 1</b> <i>Orders diagnostic testing based on patient presentation</i>	<ul style="list-style-type: none"> <li>Recognizes when to order testing for common co-ingestants (aspirin/acetaminophen) in a patient who has overdosed</li> </ul>
<b>Level 2</b> <i>Interprets diagnostic testing in the evaluation of toxicologic disease</i>	<ul style="list-style-type: none"> <li>Appropriately applies the Rumack-Matthews Nomogram in acetaminophen ingestion case</li> <li>Appropriately interprets the electrocardiogram (EKG) in a patient who overdosed and identifies sodium channel blockade</li> </ul>
<b>Level 3</b> <i>Orders advanced and ancillary diagnostic testing based on the pre-test probability of disease and the likelihood of test results altering management</i>	<ul style="list-style-type: none"> <li>Orders a heavy metal screening in a symptomatic patient</li> <li>Orders osmol gap and other ancillary testing to prioritize the differential diagnosis</li> </ul>
<b>Level 4</b> <i>Interprets advanced, ancillary, and forensic diagnostic testing</i>	<ul style="list-style-type: none"> <li>Interprets postmortem toxicology testing</li> <li>Interprets metal testing in the context of patient presentation</li> </ul>
<b>Level 5</b> <i>Develops order sets for the work up of the toxicologic patient</i>	<ul style="list-style-type: none"> <li>Develops protocols and order sets to enhance diagnostics and treatment of the patient with unknown poisoning</li> </ul>

<b>Patient Care 3: Management Plan and Treatment</b> <b>Overall Intent:</b> To develop and apply treatment plans for patients with diverse toxicologic disorders	
Milestones	Examples
<b>Level 1</b> <i>Formulates initial treatment plans for straightforward toxicologic conditions</i>	<ul style="list-style-type: none"> <li>• Formulates an initial treatment plan for a patient with a reported single, acute acetaminophen ingestion</li> </ul>
<b>Level 2</b> <i>Formulates comprehensive treatment plans for straightforward toxicologic conditions</i>	<ul style="list-style-type: none"> <li>• Formulates and oversees treatment course for a person with a massive, single acute acetaminophen ingestion</li> </ul>
<b>Level 3</b> <i>Formulates comprehensive treatment plans for complex toxicological conditions</i>	<ul style="list-style-type: none"> <li>• Formulates a treatment plan for a patient with a patient with hepatotoxicity following an acetaminophen ingestion/repeat supratherapeutic ingestion</li> <li>• Incorporate extracorporeal management plans</li> </ul>
<b>Level 4</b> <i>Implements interdisciplinary team for complex toxicological conditions</i>	<ul style="list-style-type: none"> <li>• Guides the primary service/leads the management team treating a critically ill patient with an acetaminophen ingestion and recommends when the patient should be referred for a liver transplant evaluation</li> </ul>
<b>Level 5</b> <i>Develops novel management strategies for poisonings</i>	<ul style="list-style-type: none"> <li>• Develops a protocol using adjuvant treatment methods for acetaminophen ingestion</li> </ul>

<b>Patient Care 4: Substance Use and Withdrawal</b>	
<b>Overall Intent:</b> To implement and maintain both pharmacologic and non-pharmacologic treatment modalities for patients with various substance use disorders and withdrawal syndromes	
<b>Milestones</b>	<b>Examples</b>
<b>Level 1</b> <i>Recognizes withdrawal syndromes and substance use disorders</i>	<ul style="list-style-type: none"> <li>• Describes the clinical findings in patients with opioid and alcohol withdrawal</li> <li>• Lists the findings in Opioid Use Disorder (OUD), alcohol use disorder</li> </ul>
<b>Level 2</b> <i>Formulates treatment plan for patients with straightforward substance use disorders and withdrawal syndromes</i>	<ul style="list-style-type: none"> <li>• Describes initiation process for buprenorphine and naltrexone for OUD</li> <li>• Delineates symptom-triggered therapy for sedative hypnotic withdrawal syndrome</li> <li>• Develops a treatment plan for smoking cessation</li> </ul>
<b>Level 3</b> <i>Initiates treatment of patients with complex substance use disorders and withdrawal syndromes</i>	<ul style="list-style-type: none"> <li>• Manages precipitated withdrawal</li> <li>• Starts buprenorphine induction in patients with concomitant ethanol withdrawal</li> <li>• Provides management of ethanol withdrawal in patients with pulmonary disease</li> </ul>
<b>Level 4</b> <i>Selects therapies based on prior treatment response, co-morbidities, resources, and patient preferences</i>	<ul style="list-style-type: none"> <li>• Discusses with patient the benefit and risk of pharmacotherapeutic options for OUD and alcohol use disorder</li> <li>• Selects and adjusts dose and treatment approach based on response to treatment for OUD or alcohol use disorder</li> </ul>
<b>Level 5</b> <i>Establishes holistic treatment pathways involving institutional and community resources</i>	<ul style="list-style-type: none"> <li>• Optimizes patient centered care by using counseling, encompassing more than pharmacologic treatment</li> <li>• Organizes a peer navigator program or warm handoff process to outpatient care</li> </ul>

<b>Medical Knowledge 1: Pathophysiology of Poisoning</b>	
<b>Overall Intent:</b> To understand and explain how xenobiotics interfere with human functioning at a cellular and organ-based level	
<b>Milestones</b>	<b>Examples</b>
<b>Level 1</b> <i>Discusses basic concepts of biochemistry, physiology, and pharmacology</i>	<ul style="list-style-type: none"> <li>● Explains half-life, receptor efficacy (agonist versus antagonist), and volume of distribution</li> <li>● Discriminates between sympathetic and parasympathetic effects</li> </ul>
<b>Level 2</b> <i>Describes basic toxicologic mechanisms and pathophysiology</i>	<ul style="list-style-type: none"> <li>● Describes how cocaine causes cardiac toxicity</li> <li>● Discusses how xenobiotics uncouple and inhibit oxidative phosphorylation</li> <li>● Explains how xenobiotics cause elevated anion gap acidosis</li> </ul>
<b>Level 3</b> <i>Explains advanced toxicologic mechanisms and pathophysiology</i>	<ul style="list-style-type: none"> <li>● Describes mechanisms of thalidomide teratogenicity</li> <li>● Explains mechanisms of hepatotoxicity from amatoxin, acetaminophen, and valproic acid</li> <li>● Describes the mechanism of carbon monoxide delayed neurologic sequelae</li> <li>● Discusses the management of caustic ingestion in patients who have esophageal injury</li> </ul>
<b>Level 4</b> <i>Demonstrates sufficient knowledge about the pathophysiology of complex or rare toxicological conditions</i>	<ul style="list-style-type: none"> <li>● Explains the complications in patients who are intestinal transporters of cocaine and heroin</li> <li>● Explains the pathophysiology and risk factors of pneumoconiosis</li> <li>● Describes the mechanisms of toxicant induced carcinogenicity</li> <li>● Describes the toxicities that may occur from exposures to mycotoxins</li> </ul>
<b>Level 5</b> <i>Demonstrates expertise in toxicologic pathophysiology and epidemiologic associations</i>	<ul style="list-style-type: none"> <li>● Serves on a US Food and Drug Administration (FDA) panel</li> <li>● Develop a curriculum on toxicologic mechanisms of action for medical/pharmacy students</li> </ul>

<b>Medical Knowledge 2: Population Exposure</b>	
<b>Overall Intent:</b> To describe how xenobiotic exposures adversely affect populations and means of monitoring and mitigating those risks	
<b>Milestones</b>	<b>Examples</b>
<b>Level 1</b> <i>Identifies major routes of human population exposure</i>	<ul style="list-style-type: none"> <li>• Lists potential sources for exposure in a population who live near a chemical plant</li> <li>• Lists routes through which xenobiotics can enter the body</li> </ul>
<b>Level 2</b> <i>Identifies sources of environmental exposures to chemical, physical, and biological hazards for defined populations</i>	<ul style="list-style-type: none"> <li>• Describes sources of environmental radiation exposures</li> <li>• Takes an environmental exposure history in a sample of a population to identify the source</li> </ul>
<b>Level 3</b> <i>Describes individual factors that impact susceptibility to adverse health effects from environmental exposures</i>	<ul style="list-style-type: none"> <li>• Describes the physiologic reasons for increased susceptibility of an environmental xenobiotics induced disease in the pediatric, geriatric, and pregnant populations</li> <li>• Identifies socioeconomic factors that impact the health outcomes from environmental exposures</li> </ul>
<b>Level 4</b> <i>Recommends methods of monitoring and reducing adverse environmental health effects for population</i>	<ul style="list-style-type: none"> <li>• Describes the role of air monitoring, blood xenobiotic concentration testing, water testing for general population health</li> <li>• Creates a medical surveillance program for preventative and exposure monitoring in a workplace setting</li> </ul>
<b>Level 5</b> <i>Uses data to characterize effects of exposure of a local population based on comparison with other populations</i>	<ul style="list-style-type: none"> <li>• Develops protocols to limit the exposure of populations to chemical, physical, and biological hazards</li> </ul>

<b>Medical Knowledge 3: Laboratory and Clinical Testing</b>	
<b>Overall Intent:</b> To understand the principles underlying the various types of analytic testing performed to assess xenobiotic exposure and clinical effect	
<b>Milestones</b>	<b>Examples</b>
<b>Level 1</b> <i>Selects ancillary testing needed to assess an acute exposure</i>	<ul style="list-style-type: none"> <li>● Demonstrates knowledge of laboratory principles using common ancillary testing such as fingerstick glucose, EKG, radiographs, and pulse oximetry</li> </ul>
<b>Level 2</b> <i>Interprets the results of ancillary testing for an exposure incorporating the pharmacokinetics of the xenobiotic</i>	<ul style="list-style-type: none"> <li>● Demonstrates knowledge of commonly performed toxicology testing, including limitations and methodology</li> <li>● Identifies the differences between assay methods (e.g., screening, confirmatory)</li> <li>● Interprets results of therapeutic drug monitoring</li> <li>● Uses the Rumack-Matthew Nomogram to appropriately interpret an acetaminophen concentration</li> </ul>
<b>Level 3</b> <i>Compares the analytical modalities, including appropriateness, limitations, and methodology</i>	<ul style="list-style-type: none"> <li>● Identifies types of interference and causes of false negative and false positive results</li> <li>● Compares the utility of different analytical techniques (e.g., gas chromatography mass spectrometry, thin layer chromatography, immunoassay testing) for detection of a xenobiotic</li> </ul>
<b>Level 4</b> <i>Demonstrates knowledge of advanced analytical and clinical testing including alternative matrices</i>	<ul style="list-style-type: none"> <li>● Interprets advanced testing for xenobiotic induced organ injury such as pulmonary function test, nerve conduction studies, forensic and post-mortem testing</li> <li>● Identifies biomarkers of exposure or effect</li> <li>● Compares the advantages and disadvantages of alternative testing samples such as hair, saliva, and meconium</li> <li>● Describes medicolegal issues involving workplace testing, performance enhancing drugs, and forensic testing</li> </ul>
<b>Level 5</b> <i>Develops protocols for advanced and alternative clinical testing</i>	<ul style="list-style-type: none"> <li>● Independently serves as a medical review officer</li> <li>● Participates as an expert in a medicolegal event</li> </ul>

<b>Overall Intent:</b> To understand and describe the neurobiology and pathophysiology of substance use disorder and withdrawal syndromes and the pharmacologic basis of treatment	
<b>Milestones</b>	<b>Examples</b>
<b>Level 1</b> <i>Discusses the relevant terminology of substance use, addiction, and withdrawal</i>	<ul style="list-style-type: none"> <li>● Explains the importance of non-stigmatizing language when discussing substance use disorder</li> <li>● Describes dependence, addiction, and use disorder</li> <li>● Distinguishes the various common withdrawal syndromes</li> </ul>
<b>Level 2</b> <i>Describes the biological basis, pharmacokinetics, and toxicokinetics of psychoactive and addictive substances</i>	<ul style="list-style-type: none"> <li>● Describes pharmacokinetics/ pharmacodynamics of tolerance</li> <li>● Describes pharmacokinetics and pharmacodynamics of dependence and withdrawal</li> <li>● Explains the basic role of risk-reward in addiction</li> <li>● Describes the role of the limbic system in euphoria</li> </ul>
